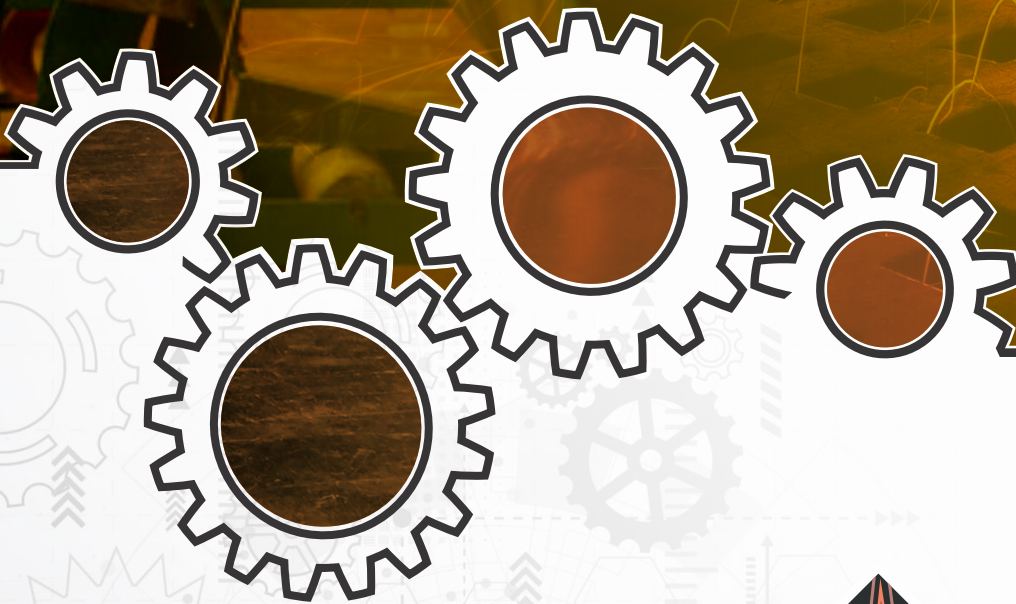

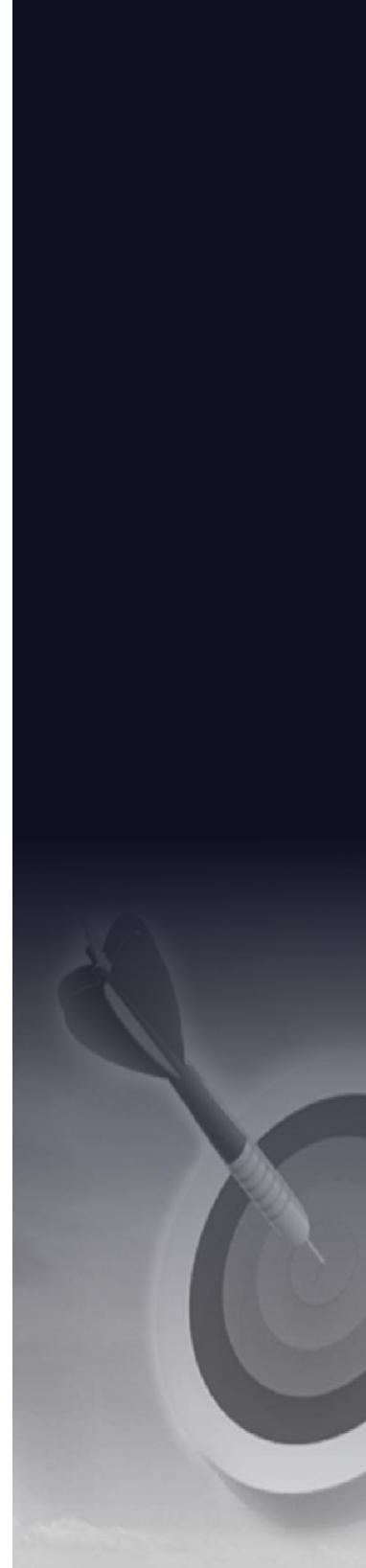

About AWPM

The Association of Welding Products Manufacturers (AWPM) was established during Year 2005, at the initiatives of some of the leading manufacturers of welding products in India. The association was registered on 8th February 2005 with the Registrar, Greater Bombay Region, Maharashtra Government. The AWPM was basically established to bring all the manufacturers of welding products together, set their objectives and aims, take up various issues regarding overall business of Welding Products in India, as and when required, with CII & Government of India, and initiate all the actions required for technological and business growth of Indian Welding Industry to match with International level. AWPM has about 24 members as of Jan' 2020.

Why Welding Industry is important for growth of Indian economy

Welding is indispensable to all manufacturing industries. It is considered as a special manufacturing process and therefore very critical process for all manufacturing activities. With development of material science, newer materials of better mechanical properties are becoming available on one hand. On the other hand, due to technological development in Electronic field, welding processes are modified and improved day by day. This has enhanced welding efficiency & productivity multifold. Use of welding processes has increased in all the industries for metal joining applications. As a result of this, one cannot imagine the development and manufacturing of new products like Super critical boilers, satellites like Mangalyan, Defence equipments like main battle tank, long range missiles, Heavy mechanical structures for high pressure, low & high temperature applications etc without the use of welding processes. With growth of steel industry steel production has increased multifold in last few decades, which has fuelled the welding & fabrication activities rapidly across all industry sectors. 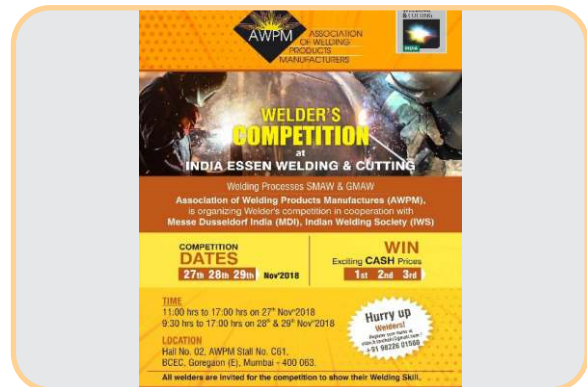

Following are the main points of the Interactive session with Hon'ble Minister Shri Piyush Goyal, Commerce and Industry Ministry and Shri Jitin Prasada, State Minister of Commerce and Industry, held on 20th August at Vanijya Bhavan, New Delhi

1. Apart from AWPM, various other associations were invited for the Interactive Session with the Ministers mentioned above
2. The meeting started with a brief by the Minister of State of Commerce and Industry Shri Jitin Prasada and Secretary-DPIIT about condition of economy and policies and how they are looking to industry feedback about policies from the various stake holders.
3. The complete industry with all secretaries were present and it was quite an interactive session with government demonstrating their intent to act swiftly. In the most cases secretaries were answering back immediate with the data and were well informed.
4. Shri Piyush Goyal was very proactive and said this meeting is called by us and not CII or the industry. He was rather complaining that industry was not proactive. He said that whenever you feel India is getting hurt by any country due to a trade policy, come forward and show us the proof and we will also act to hurt the other side so that trade off takes place. Also he wanted industry to use the Commerce Industry Portal, which is one point solution having time bound action
5. Bharat Mart - An GOI initiative in the Middle East (Dubai) where they will have office and warehousing space available for Indian manufacturers to push their products in the Middle East region
6. Welding Robots manufacturing is coming in India
7. National Single Window System by government will help making approvals faster through online/digital system.
8. 1 lakh Cr Anusandhan Fund meant for R&D is available for Industry to use.
9. He further gave many examples where India acted swiftly whenever Industry provided proof like in case of Steel Industry recently.
10. We from AWPM, spoke about Rutile scarcity, Research in Welding to become self-sufficient through use of R&D fund, welding education etc. He told us to take appointment with his team and work with them.
11. We now intent to meet the secretary in the Ministry of Heavy Industry to escalate the matter.
